Invitation to Bid For
PROPOSED COMPLETION OF INFORMATION AND COMMUNICATION TECHNOLOGY
CENTER (ICTC) BLDG PHASE II-B

1. The *MSU-Iligan Institute of Technology*, through the *General Appropriations Act-2014 (GAA-2014)* intends to apply the sum of **FORTY ONE MILLION SIX HUNDRED FIVE THOUSAND PESOS (PhP41,605,000.00)** being the Approved Budget for the Contract (ABC) to payments for the contract for the **PROPOSED COMPLETION OF INFORMATION AND COMMUNICATION TECHNOLOGY CENTER (ICTC) BLDG., PHASE II – B** with *Project Reference No. 2014-086*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *MSU- Iligan Institute of Technology* now invites bids for the Construction of **Information and Communication Technology Center (ICTC) Bldg., Phase II - B**. Completion of the Works is required within *one hundred eighty (180) calendar days* from the starting date indicated in the Notice to Proceed. The Scope of Works of the project includes: Mobilization and Demobilization; Third Floor up to Roof Deck: Concrete and Masonry Works, Carpentry Works and Finished Hardwares; Plumbing Works; Tile Works; Steel Works and Roofing; Electrical Works; Painting Works; Elevator Machine; Automatic fire sprinkler and manual alarm system.
3. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184),

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from *MSU-Iligan Institute of Technology Bids and Awards (BAC) Secretariat* and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM (Philippine Standard Time (PST))**, during regular working days.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **PhP25,000.00**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
7. The *MSU Iligan Institute of Technology* will hold a **Pre-Bid Conference** on **August 22, 2:00 PM (PST) at Legal Office**, MSU-IIT Campus, Tibanga, Iligan City, which shall be open TO ALL INTERESTED BIDDERS.
8. Bids must be delivered to the address below on or before **September 5, 2014, 2:00 PM (PST)**, at the **MSU-IIT BAC Secretariat Office**, MSU-IIT Campus, Tibanga, Iligan City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
9. Bid opening shall be on **September 5, 2:00 PM (PST)** at **MSU-IIT Boardroom**, MSU-IIT Campus, Tibanga, given address. Late bids shall not be accepted.
10. The *MSU Iligan Institute of Technology* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
